

Terms and conditions
“110 YEARS WECO” VISIONIX
From 07/25/2024 to 10/31/2024

ARTICLE 1 - ORGANIZING COMPANY

The Company VISIONIX INTERNATIONAL SAS with capital of 5,789,104.00 euros, whose head office is 2 rue Roger Bonnet – 27340 PONT DE L'ARCHE, registered in the Evreux Trade and Companies Register no. B 482 975 083 (hereinafter referred to as the “Organizer”), is organizing, as part of the “110 YEARS WECO” operation, a free competition with no obligation to purchase from July 10, 2024 8 p.m. to October 31, 2024 8 p.m. inclusive for its partners, entitled “110 YEARS WECO” (hereinafter referred to as “the Operation”).

The operation is governed by these regulations, accessible on the website <https://www.110-years-weco.com/>.

ARTICLE 2 - DURATION

The “110 YEARS WECO” operation is organized from July 25, 2024, 8 p.m. to October 31, 2024, 8 p.m. inclusive .

The Organizer reserves the right at any time and without notice to shorten, extend, modify, cancel or suspend the Operation due to any event beyond its control, without liability being incurred. for this reason.

ARTICLE 3 - PARTICIPATION

The “110 YEARS WECO” operation is open to any adult natural person.

Any incomplete, inaccurate or fanciful registration will not be taken into account.

The Organizing Company reserves the right to verify that the winners participated in the Operation under conditions consistent with these regulations, non-compliance with the conditions laid down by these regulations leading to the nullity of the non-compliant participation(s), disqualification of the winner(s) and the cancellation of his/her/their winnings, without prejudice to any actions for compensation for the damage suffered by the Organizing Company.

The winners authorize all verifications concerning their identity.

ARTICLE 4 - TERMS OF THE OPERATION

To participate and validate their registration for the Operation, the participant must go to the site <https://www.110-years-weco.com/>, then click on 'SHARE MY MEMORY.

Participants must complete a participation form by uploading a souvenir photo, its title and its comment ('anecdote'), then by providing their name, first name, email address, country and accept the rules of the Operation, then to validate.

Once the form is completed and their participation validated, it is recorded.

Any participation that is incomplete or contains erroneous information will be considered void.

The "110 YEARS WECO" operation will reward the 25 participants who obtained the most votes on a published photo. The distribution of allocations is detailed in Article 6 below.

The winners will only be able to consider the prize as definitively acquired after receipt of an official email from the Organizer and confirmation within the deadlines detailed in article 7 below.

At the end of a period of five (5) calendar days, without a response to the email sent by the Organizing Company, the silence of the winner(s) will constitute pure and simple

renunciation of their (their) Prize and it will be lost. It may be assigned to another participant.

ARTICLE 8 - PRIZE DELIVERY

These prizes will be shipped by VISIONIX, within approximately twenty-one (21) working days from the date of acceptance of the lot.

If the winners' contact details are unusable (incomplete or incorrect), they will lose the benefit of their Prize which will remain the property of the Organizing Company which reserves the right to put it back into Operation in this same operation or in a subsequent operation.

Prizes not claimed by the winners within the allotted time or returned to the Organizing Company due to non-receipt by the winners will not be put back into the Operation.

The Organizing Company cannot be held responsible for delays or losses caused to elements relating to the prizes during their delivery. ARTICLE 13 - INTELLECTUAL PROPERTY - IMAGE RIGHT

The winners, as part of the event and solely because of their participation in the "110 YEARS WECO" operation, freely authorize the use of the photograph(s) transmitted by the participant, the slides, the fixation on electronic media, film, paper, videograms or any other medium, their image, surnames, first names, speeches in full or in extracts to reproduce them on any type of medium, digitize, represent by any mode of public representation, in particular television or all telecommunications services, cable distribution, on all networks including the Internet and in all territories. ARTICLE 14 - "COMPUTER AND FREEDOM" LAW and GDPR

be communicated to service providers and subcontractors for the execution of work carried out on its behalf within the framework of this Operation.

In accordance with law n°78-17 of January 6, 1978 as amended and from its entry into force on May 25, 2018, the general data protection regulation n°2016/679 (hereinafter the GDPR) each participant has the right of access, rectification, erasure, in particular to request the erasure of their personal data, if they were collected when they were a minor, or a limitation of the processing, or the right to object to the processing, and the right to portability of personal data concerning him

The data collected as part of this Operation is processed in compliance with the provisions of the General Data Protection Regulation, which entered into force on May 25, 2018.
